Wetlands Management By Allstate Resource Management, Inc.

Desirable wetland plant species are important components of a balanced aquatic ecosystem. The aesthetic and wildlife habitat value of lakes, ponds and storm water retention basins can be greatly enhanced by planting and maintaining created sanctuary areas with beneficial wetland plants.

A detailed plan of a mitigation site (wetland) is necessary – and usually required - for approval by district agencies. Plants and diagrams of planting zones help installers plant the area in such a way that is both correctly done and in compliance with jurisdictional agency mandates. Planting plans may cost between \$1,500 and \$15,000 depending on the magnitude of the project. Before starting any planting program, it is wise to check plant materials and any changes in regulations with local water control administration.

Companies in the industry that provide plants can also provide planting services and installation. After a site has been prepared and the groundwork completed, a planted acre of commonly used wetland plants can require an additional investment between \$3,600 and \$13,500. The average cost of individual herbaceous aquatic plants suitable for use in “aquascaping” runs from 48 cents to \$5.00 each. Installation by professional staff to ensure survival is additional.
